

SPECIAL TOPIC WORKSHOP #6 CHAT AND POLL SUMMARY

KENT NARROWS COMMUNITY PLAN



The purpose of this workshop was to solicit input from the community on topics related to the comprehensive plan as it relates to the Kent Narrows Community Plan. Below is a summary of the chat conversations and poll responses received during this meeting, held on Thursday, April 29th, 2021 at 9:00am.

108. 10:06 AM Regarding impervious surfaces, we need alternate surfaces, which are approved by the county, that allow better water flow. In other counties, grassy pavers, etc. are considered pervious so they are more regularly used. I think in QAC, grassy pavers are considered impervious, so there is no incentive to use them.
